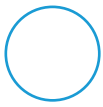

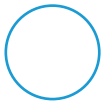

What next for The Strand?

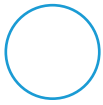
If you are unfamiliar with the road layout, refer to diagrams here (www.fndc.govt.nz/Whats-New/Have-your-say)



Keep the current trial layout - Shared space from Seaside Café to the boat ramp. Pedestrian priority zone from Cass Street to the Marae, with access for essential vehicles only. 'No Left Turn' sign to remain on Cass Street.



Remove the trial layout and return The Strand to its original setup.



Full pedestrian priority zone from the boat ramp to the Marae (not funded) with access for essential vehicles only.
