Earthworks - Overview of Submissions



- 46 original submissions (193 submission points)
- 43 further submitters (320 submission points)

Submissions from:

- Primary sector submitters (e.g. Federated Farmers, Hort NZ, forestry submitters)
- Infrastructure providers (e.g. Transpower, Top Energy, Telco Companies)
- Government agencies (e.g. NRC, Heritage NZ, DOC)
- Planning and engineering firms (e.g. Northland Planning and Development Limited)

Earthworks - Key matters raised



- Duplication and overlap with regional controls on earthworks by NRC under the Northland Regional Plan (NRP).
- Unnecessary duplication between PDP earthworks rules that require compliance with the same earthworks standards.
- The need to provide for earthworks associated with all primary production activities.
- Concerns that some of the earthworks standards are too stringent and/or uncertain.
- Requests for exemptions to certain earthworks rules and standards for range of activities.

Earthworks - Key s42A recommendations



- Remove/refine provisions that are primarily regional council functions (e.g. effects on water bodies)
- Replace rules with a single earthworks rule (EW-R1) that permits earthworks subject compliance with all earthworks standards (EW-S1 to EW-S9).
- Provides a more effective and effects-based rule framework that is generally supported.
- A range of targeted exemptions to earthworks standards for certain common/low risk activities.
- For example:
 - EW-S1 (thresholds) maintenance of existing tracks and roads, septic tanks, maintenance of drains
 - EW-S2 (cut and fill) land disturbance
 - EW-S6 (setbacks) land disturbance, infrastructure and utility connections, formation of driveway or crossing

Earthworks – Outstanding issues in evidence



- A number of submitters support the section 42A recommendations
- Outstanding issues in pre-circulated evidence:
 - Requested rule for earthworks to be setback to archeological sites (Heritage NZ)
 - Exemptions to EW-S1 for infrastructure (Top Energy) and common activities (Waitangi Limited)
 - Exemptions to EW-S2 for telecommunication pole foundations (Telco Companies)
 - Earthworks rules in National Grid Yard (Transpower) and near Critical Electricity Lines (Top Energy)

Noise and Light - Overview of Submissions



Noise and Light

- 38 original submitters (170 submission points)
- 25 further submitters (263 submission points)
- Submissions came from Government agencies, iwi groups, community interest groups, the primary production sector, landowners and others. These submissions covered a range of matters.

Noise - Key Matters for Consideration




- Helicopter landing areas provisions.
- Definitions
- Additional noise provisions for rail lines.
- Noise provisions that relate to State Highways.
- Giving effect to the RPS within the objectives and policies in relation to avoiding reverse sensitivity effects on lawfully established noise-generating activities.
- Exemption from noise provisions for generators and mobile equipment used for emergency purposes, including testing and maintenance.
- Additional noise provisions specific to substations.
- Permitted times for the use of audible bird scaring devices.
- Interrelationship between zone noise limits, particularly between the Heavy Industrial zone and Open Space zones.

Key issues

- Clarification and interpretation matters
 - New definitions and amended SIGN-R10 and note 1, table 1
- Maximum area and height of signs
 - Amended sign height limits SIGN-S2
- Visual clutter reduction
- Temporary signs and community signs
 - Amended SIGN-R3 to reduce duration of temp signs
- Third party signs
- Exemptions from compliance
 - Exemptions in SIGN-S1 and SIGN-S3 for Waitangi Estate
- Transport and network safety
 - Minot amendments to SIGN-P4
- General matters
 - Amendments SIGN-R7 PER-3 lawfully established, New rule digital signs in Light industrial zone
